Sealed Tender is invited for empanelment or service provider from prospective bidders from experienced, individual, artisans, agencies/SHGs/organization, textile industries under two bid system for Value Addition (Dying, Washing, Screen & Digital Printing, Polishing, Stitching, Designing, Embroidery, Hand Painting, etc) of Cotton/Silk/Khadi Products under two bid system –

1. Technical Bid
2. Financial Bid

Technical & Financial bid shall be submitted in two separate sealed envelopes. Both envelopes shall be kept in a bigger sealed envelope. Envelops shall be super scribed as "Technical Bid" and "Financial Bid". Bidder envelop shall be super scribed as "Tender for Value Addition in JSKVIB, Ranchi" (NIT No -03/JSKVIB/2023-24)

TERMS AND CONDITION

The format for Technical bid and Financial bid item wise is specified an Annexure I & II, which should be used at the time of submission of Tender.

General Terms and Condition:

1. The bidder should submit single price bid for items mentioned in Annexure – I.
2. Bids received physically after due date & time will not be accepted.
3. Bid shall be valid for 60 days from the opening of bid.
4. Each bidder shall submit only one bid for all items. Conditional offers shall not be accepted.
5. The price shall be quoted in Indian Rupees only.
6. No advance payment will be made by the Board.
7. The Tender will be opened in the presence of Tenderer or there representative, if any, in the official chamber of CEO Jharkhand State Khadi and Village Industries Board, Ratu Road, Ranchi.
8. Notwithstanding the above, the undersigned reserves the right to accept or reject any bid(s) and to cancel the bidding process at any time prior to the issue of work Order without assigning any reason thereof.
9. Payment shall be made after completing official process on delivery of goods according of the work order and submission invoices and challan etc.
10. Tender should be properly signed, stamped and sealed.
11. Any legal disputes arising out of this is subject to the court of Ranchi jurisdiction only.
12. Rate quoted will be valid up to 60 Days and may also be extended as per mutual consent.
13. All Tenderers who declared successful on the basis of their technical bid will deemed to be empanelled in Board for rendering service.
14. Normally the work will be allotted to lowest Tenderer but it will be the sole discretion of undersigned to allot the work to the lowest Tenderer or to any empanelled Tenderer on lowest rate, after taking into the consideration of requirement/volume/time limit of work.



Technical Bid Terms and Condition:

1. Non-refundable Tender Fee amount of Rs. 5,000/- (Five Thousand) for washing, Dyeing, Polishing, Finishing work and Rs.1000/- (One Thousand) for other each work or group of works, whichever is applicable in the form of demand draft of any nationalized bank in the favour of Jharkhand State Khadi & Village Industries Board payable at Ranchi as Tender fee to be submitted with the technical bid.
2. (i) Earnest Money amounting to Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand) for washing, Dying, Polishing, finishing work and Rs. 10,000/- (Rupees ten thousand) for others or Bidder is applicable shall be submitted in form of or NSC or post office term deposit or post office savings bank passbook duly pledged in favour of Chief Executive Officer "Jharkhand State Khadi & Village Industries Board". Bank draft issued from scheduled bank in favour "Jharkhand State Khadi & Village Industries Board" payable at Ranchi, may also be furnished in place of above instruments. The Tender without earnest money will not be considered.

(ii) Earnest money to unsuccessful Tenderer shall be return and that of successful Tenderer shall be kept as performance guarantee, which will be returned after contract period.
3. The bidder's turnover should be at least Rs. 50 Lakh for washing, Dying, Polishing, Finishing supported by CA's turnover certificate and 10 lakh for others, but in any case of SHGs should be 2 Lakh in any financial year 2019-2020 and 2020-2021 and 2021-22.
4. Affidavit from notary for declaration regarding organization has not been declared blacklisted to be provided on Rs.100/- (One Hundred) Non judicial stamp paper.
5. The Tenderer has to submit self attested copies of ITR of last three years, copy of PAN CARD, GST registration certificate and Audited balance sheet of last three years, income Tax and sales Tax /GST clearance certificate, labour license.

Financial Bid Terms and Condition:

1. TDS on all Taxes (Income Tax & GST etc) shall be applicable as per Govt. Rules/Order issued from time to time.
2. Rate should be quoted excluding GST.
3. Evaluation will be made as per the lowest quoted rate.

SPECIAL TERMS AND CONDITION WASHING, DYEING, POLISHING, FINISHING WORK

General Terms & Conditions

1. Estimated cost of work shall be approximate around 35 Lakh per annum.
2. Work order shall be given as per requirement from time to time.
3. Contractor shall obtain list of specified colour/dye for the specified cloth from the JSKVIB as the cloths is received and shall return finished cloths in all respect within 21 days.
4. The contractor shall have to ensure non-fading of colours. In the case of fading, contractor will have to rectify without compromising with the quality of cloth otherwise along with transportation cost, the cost of cloth shall be recovered from the unpaid bills or performance guarantee of the contractor.
5. Tenderer shall quote rates separately for silk & cotton cloths.

Technical Terms & Conditions

1. Tenderer shall be preferred registered under MSME.
2. They have to submit an affidavit to the effect that they will use only. AZO free colours/colours permitted by government.
3. The Tenderer shall have to submit:
 - a. Registration certificate for MSME (in the case of MSME registered bidder)
 - b. NOC/clearance from Pollution Control Board with their validity period (if any).
4. Quality test report (if any) from the government of Jharkhand authorized recognized institutions in respect of Sample furnished at the time of technical bid.
5. The Tenderer shall submit Bank guarantee from a scheduled bank of Rs. 1, 50,000/- (One Lac Fifty Thousand) in favour of Jharkhand State Khadi & Village Industries Board on the date of publication of NIT.

Eligibility criteria

1. Valid GST Registration Certificate in handicrafts items or general order supply.
2. Turnover certificate, ITR, Balance Sheet (Audited) for the last three years.
3. Tender should be properly signed and stamped.
4. Declaration on Rs. 100/- (One Hundred) Non judicial stamp paper having not declared as blacklisted by the government of government undertaking.
5. Experience not less than three years in respective field. The date of publishing of NIT.

Note: The bid shall be rejected, if any of the above conditions is not complied with superscribed as Technical/Financial as applicable.

The bidder shall submit their bid in two separate envelop packed in another single outer envelope super scribed as "Tender Inviting Offers for value addition work".
